 expanded. Reach out to East Columbus Civic Association to work with them too. We also should include
 City Councilmember over the environmental committee.

- Elections/Bylaws Procedures: Alfonso Hooper Tiffany White, Bee Tolber, and Lamar Peoples.
 - Need to hold committee meeting.
- SmartCity: Linden Community Plan Working groups in the first quarter of 2018. These will be the last planning meetings and then a consultant will implement (it's not currently agreed upon for neighborhood input to be required during implementation process). It is important that we go to show our area has support and request assets we need (i.e., pharmacy, grocery, etc. on public transportation).
 - Mayo Makinde went to Clinton township meeting. Problem is that outrage is on social media, hard to take other direct action. We need to approach Council about bringing a developer; consider asking the Mid-Ohio Food Bank to have a satellite office.
 - o Current plan does include a grocery store in Linden.
 - o Lamar Peoples looked up North Central on healthyfoodaccess.org. The website reported ECDI is using money on plaza market grocery store and community food commissary.
 - o In the past, Director Schoeny has said that once the houses come, then the businesses will come.
 - o So how do we pursue this next?
