Meeting Minutes for September 3, 2020: One change – Alfonso Hooper was excused last month. Asmara Williams motioned to approve. Reno Lemons seconded. All in favor.

City Reports:

 - Tray Lee Center This is not a City owned property (Amer Crest Improvement Group is owner).
 The concern is whether only one person has control since the rest of the board has passed away (this person lives out of town). The building is not being kept up the roof is caving in. She will refer to Code Enforcement.
 - Williams Coles at a park he is not prohibited from being there but currently under indictment by Franklin County Sheriff's office.

 - A-Z Recycling under review for filing (hopefully more updates next month). The fence at 1547 is not a Code violation but will double check the 1579 Joyce (runs along 17th Metro Auto).
 - Other properties we reported to them are on their radar. If we suspect any prostitution, drug activity, violence, contact police and then follow-up with her.

Presentations:

• **Creekside Place Project** – Laurie Sutherland from Community Housing Network. They are framing the third floor today, roof will be built by the end of the month – on schedule to be completed early. They are

not hiring yet. The Good Neighbor Agreement was sent and also the Community Advisory Council is where we can express concerns; also generate good ideas here too.

- Laura Comek Smart Truck Express LLC at 1440 Joyce Avenue; Bashir Mohammed is owner.
 - o Current zoning is M2 manufacturing, proposed use is truck storage (allowable in M2). Acquired 3 lots (8 acres) from Wallace McLean – already allows this use; but wants to change current setbacks.
 - He also owns properties at 16th and Joyce and is acquiring other land that is zoned residential.
 - They are currently in Phase 2 of their three phase plan; right now just trying to expand space they can use (reduce setback). Would like to do buffering – add a 6 foot privacy fence (phase 3 – maybe additional landscaping) near adjacent residential and commercial properties. They plan to do green space along Windsor and Joyce; keep trees on far eastside of property and eventually want access off of Windsor. This site has a barbed wire fence – would like to keep barbed wire but not sure right now if City will allow it. Paving is part of the plan but not until phase 3.
 - In contract for properties along the south of Windsor (between Cushing and Erickson alley's) and properties between Wentworth and Delbert (not sure of future use, not asking for re-zoning; Tidwell family wanted to sell all lots, they will close soon on these).
 - Our area plan is for more commercial or residential trying to build homes in this area, not manufacturing. So our concerns are: What hours would the trucks be coming in/out? We would like something more to block it out noise, trucks, some lighting. We would like real surfacing; the - no trucks back against the housing area. We are concerned about activity (wear and tear on road).
 - He intends to bring jobs to the area. This is a truck storage business; there will be security at all times; trailers would be coming in/out between 8 and 3 (maybe 4-5 a day). 18 security camera to be installed, they do not want anyone coming in at night. Not their intention to have anything hazardous there; have to do a rain water study.
 - o BZA not scheduled right now, still working with us will come back next month after discussing with neighbors (particularly lighting, fencing, landscaping).

Considering P and D builders (same who did the extreme makeover home) since they are familiar with the neighborhood.
